GENERAL CONDITIONS FOR BOOKING A PITCH

The campsite Orgatte accepts site reservations in order to guarantee its customers a site for the day of their arrival. These are subject to certain conditions:

The signatory of the contract must be of legal age.

Reservations are made only using this contract and will only become final upon receipt of a deposit of 20% of the amount of the stay + € 13 non-refundable administration fees in the event of cancellation whatever the reason.

The balance of the stay will be payable on arrival. For long stays (more than 1 month) possibility of paying each beginning of the month after agreement of the Management.

Your reservation will be considered final as soon as it has been the subject of a written confirmation.

Arrivals are from 2:00 p.m. and departures before 12:00 p.m.

An additional night will be charged for any overrun after 2 p.m.

From 1^{er} July to August 31, and, for better organization and in the interest of our customers, the minimum stay is 3 nights.

The sums paid as a deposit will remain with the lessor.

Only one installation is authorized per location and no more than 2 vehicles per location.

The "bicycle reception" sites are likely to accommodate up to 6 people on the same site for a maximum of 3 nights.

Any modification to the contract must be reported before arrival. Any additional person not registered will be accepted only after agreement of the Management and, in compliance with security standards. The campsite reserves the right to refuse access to groups or families arriving with a number of participants greater than 6 people.

In order to keep its location, the tenant must warn of a possible delay. Otherwise, and within 24 hours, the rental will be canceled without refund and the manager reserves the right to dispose of the location.

Minors must imperatively be accompanied by their parents.

The person in charge reserves the right to expel any person not respecting the rules or causing nuisance to others.

PAYMENT CHOICE

Payment can be made by holiday vouchers, bank check payable to the municipal campsite. Orgatte, bank transfer, credit card.

CANCELATION

Any cancellation must be notified to us by registered mail with return receipt. The campsite will not refund any cancellation for any reason. The sums paid will remain acquired.

An early departure will not give rise to any reimbursement.

When booking, an acknowledgment of receipt and a proforma invoice will confirm the payment of the deposit and specify the amount of the balance to be paid.

The rental is personal and nominative, it cannot under any circumstances be transferred or sublet.

When you make your reservation, you will be given a pitch number. However, this number is not contractual.

The invoice will be issued in the name given when booking.

DEAD GARAGE

Equipment cannot be left unoccupied on the ground, only after agreement from the management and only at the location indicated. A fee, the amount of which will be displayed at the office, will be due. There will be no parking garage during the months of July and August.

PETS

Pets are accepted (except 1st and 2nd category) provided they are kept on a leash or tied. In any case, they should not be left alone in the facilities in the absence of their owners. 2 animals maximum per pitch.

RESPONSIBILITY

The campsite will not be held liable in the event of theft, loss or damage of any kind during or following the stay, breakdown or decommissioning of technical equipment.

At night, there must be total silence between 11 p.m. and 7 a.m., no car traffic.

The site must be kept in perfect condition.

Tenants are responsible for their barbecue in the event of fire and accidents.

Only gas or electric barbecues are authorized.

In the event of non-compliance with the internal regulations causing discomfort for others, and, after formal notice, the management reserves the right to terminate the contract without compensation

MEDIATOR

In the event of a dispute and after entering the "customer" service of the establishment, any customer of the campsite has the possibility of entering into a consumer mediator.
