GENERAL TERMS AND CONDITIONS FOR BOOKING A PITCH

Camping l'Orgate accepts pitch reservations in order to guarantee its customers a pitch for the day of their arrival. These are subject to certain conditions:

The signatory of the contract must be of legal age.

Bookings can only be made using this contract and will only become final upon receipt of a deposit of 20% of the amount of the stay + 14€ non-refundable administration fee in case of cancellation for any reason. Upon booking, an acknowledgment of receipt and a proforma invoice will confirm the payment of the deposit and specify the amount of the balance to be paid.

Your booking will be considered final as soon as it has been confirmed in writing. Any inaccurate declaration will render the contract null and void, the deposit and the administration fees will remain with the lessor. All the information on this contract will be used to issue the invoice. The rental is personal and nominative, it cannot be transferred or sublet under any circumstances.

When you make your reservation, you will be assigned a pitch number. However, this number is not contractual, and can be changed before your arrival.

The invoice will be issued in the name given at the time of booking

The balance of the stay will be payable on arrival. For long stays (more than 1 month) it is possible to pay at the beginning of each month after approval by the Management.

Check-in is from 14:00 and check-out before 12:00.

An extra night will be charged for any overage after 2pm.

From July 1st to August 31st, and for better organization and in the interest of our customers, the minimum stay will be 3 nights.

Only one facility and a maximum of 2 vehicles per pitch (2nd vehicle for an additional fee)

The "bike welcome" pitches are likely to accommodate up to 6 people on the same pitch for a maximum of 3 nights.

Any changes to the contract must be reported prior to arrival. Any additional person who is not registered will only be accepted with the agreement of the Management and in compliance with safety standards. The campsite reserves the right to refuse access to groups or families with a maximum number of participants of more than 6 people.

In order to keep the pitch, the tenant must warn of a possible delay. Otherwise, and within 24 hours, the rental will be cancelled without refund and the person in charge reserves the right to dispose of the pitch.

Minors must be accompanied by their parents.

The person in charge reserves the right to expel any person who does not comply with the rules or causes a nuisance to others.

METHOD OF PAYMENT

Payment can be made in holiday vouchers, bank cheque made out to the municipal campsite l'Orgatte, bank transfer, card bancaire.et cash

CANCELLATION

Any cancellation must be notified to us by registered mail with acknowledgment. The campsite does not make any refunds in the event of cancellation for any reason. The sums paid will remain forfeited, likewise, in the event of early departure, no refund will be made except in cases of force majeure (death, illness of a participant in the stay, and, compulsorily, upon presentation of proof.

DEAD GARAGE

Unoccupied equipment may be left on the ground only with the approval of the management and only in the location indicated. A fee will be payable, the amount of which will be posted at the office. There will be no dead garages during the months of July and August.

PETS

Pets (except category 1 and 2 and NAC) are accepted for a fee provided they are kept on a leash or tethered. Under no circumstances should they be left alone in the facilities in the absence of their owners. Maximum 2 animals per pitch.

PRICE OF MATERIALS

A security deposit of 30€ will be required when borrowing equipment (BB chair, European plug, iron)

This will be cashed in case of non-return of the equipment

RESPONSIBILITY

The campsite will not be held liable in the event of theft, loss or damage of any kind during or following the stay, breakdown or disengagement of technical equipment.

At night, there must be total silence between 11 p.m. and 7 a.m., no car traffic.

The pitch must be kept in perfect condition.

Tenants are responsible for their barbecue in case of fire and accidents.

Only electric barbecues are allowed.

in the event of non-compliance with the internal rules causing inconvenience to others, and, after formal notice, the management reserves the right to terminate the contract without compensation

MEDIATOR

In the event of a dispute and after referring the matter to the establishment's "customer" service, any customer of the campsite has the possibility of referring the matter to a consumer mediator.
